The Business Meeting of Seminole City Council was held on Tuesday, January 14, 2014 at 7:00 p.m., in City Hall, City Council Chambers, 9199 - 113th Street North, Seminole, Florida.

Mayor Waters called the meeting to order at 7:00 p.m. Councilor Matthews provided the invocation and Pledge of Allegiance.

City Manager Edmunds introduced the new Seminole Fire Chief, Heather Burford. Fire Chief Burford said that she is pleased to be the newly appointed Chief of Seminole Fire Rescue. City Clerk Benoit read Ordinance No. 14-2013 by title only. Mayor Waters recognized City Manager Edmunds. City Manager Edmunds stated that the estimated fund balance for FY14 is \$294,100. The allocation of the funds is in accordance to council goals. Mayor Waters opened the Public Hearing. Receiving no other Public Comments, the Public Hearing was closed. # 4. <u>CONSIDER APPROVAL OF REVISED RESOLUTION NO. 14-2013 REGARDING DUKE ENERGY.</u>

City Clerk Benoit read revised Resolution No. 14-2013 by title only. Mayor Waters recognized City Manager Edmunds. City Manager Edmunds said that revised Resolution No. 14-2013 was approved during the December 10, 2013 business meeting, but that prior to distributing, required minor language changes were made. Intent and purpose of revised Resolution No 14-2013 remains the same. Motion made by Councilor Burke seconded by Councilor Quinn to adopt revised Resolution No. 14-2013.

## 5. <u>CONSIDER AUTHORIZATION TO EXPEND CONTINGENCY FUNDS NOT TO EXCEED</u> \$6,000.00 FOR THE DEMOLITION OF AN UNSAFE STRUCTURE LOCATED AT 10148 – 66TH AVENUE.

Mayor Waters recognized City Manager Edmunds. City Manager Edmunds stated this is an unusual step on the city's behalf; however the property has fallen into disrepair. He stated that the property has become a safety concern. Motion made by Councilor Quinn seconded by Councilor Matthews to approve the expenditure not to exceed \$6,000.00 from the contingency account for the demolition of the unsafe structure located at  $10148 - 66^{th}$  Avenue.

# 6. CONSIDER AN APPOINTMENT OF A CITY REPRESENTATIVE TO THE PINELLAS COUNTY COLLABORATIVE EFFORT REGARDING CHANGES TO THE NATIONAL FLOOD INSURANCE PROGRAM.

Mayor Waters recognized City Manager Edmunds. City Manager Edmunds referenced letter received from Pinellas County Chairman, Kenneth Welch and Chair-Elect Karen Seel. The letter indicates their plan to establish a collaborative effort with all Pinellas County municipalities to address the changes to the National Flood Insurance Program. Motion made by Councilor Matthews seconded by Councilor Quinn to appoint Vice Mayor Barnhorn as the City of Seminole's representative for the Pinellas County collaborative effort regarding changes to the National Flood Insurance Program.

# 7. CONSIDER A RE-APPOINTMENT OF MR. ROBERT HUTTICK TO THE TREE ADVISORY COMMITTEE FOR A THREE YEAR TERM.

Mayor Waters recognized City Manager Edmunds. City Manager Edmunds stated that this item and the next are two re-appointments to the Tree Advisory Committee. He stated that both individuals are active in the committee and demonstrate sincere interest in committee activities.

Motion made by Councilor Quinn seconded by Councilor Matthews to re-appoint Mr. Robert Huttick to the Tree Advisory Committee for a three (3) year term that will expire January 25, 2017.
