The Business Meeting of Seminole City Council was held on Tuesday, November 24, 2015, at 7:00 p.m., in City Hall, City Council Chambers, 9199 - 113th Street North, Seminole, Florida.

1. OATH OF OFFICE

Councilor Chris Burke and Councilor Trish Springer were sworn-in by Attorney Daigneault.

Mayor Waters presented Councilor Burke and Councilor Springer with a Key to the City lapel pin and presented Councilor Springer with an American Flag lapel pin.

3. APPROVAL OF MINUTES – MEETING MINUTES OF NOVEMBER 10, 2015.

Motion made by Councilor Quinn seconded by Councilor Burke to approve the Business Meeting Minutes of November 10, 2015.

4. ELECTION OF A VICE-MAYOR

Mayor Waters opened the floor for Vice-Mayor nominations. Councilor Burke and Councilor Quinn self-nominated.

City Clerk Beliveau announced Councilor Quinn received five votes and Councilor Burke received two votes. Councilor Quinn was elected Vice-Mayor.

5. CONSIDER APPROVAL OF RANKING AND AUTHORIZE THE CITY MANAGER TO NEGOTIATE TERMS OF AN AGREEMENT FOR GENERAL ENGINEERING SERVICES.

Mayor Waters recognized City Manager Toney-Deal to explain. City Manager Toney-Deal explained the process of selecting General Engineering Services. The initial list of firms responding to the Request for Qualifications (RFQ) was narrowed to five engineering services firms based on the submittals reviewed. The firms were then interviewed by staff. Following the interviews, Staff then ranked the firms and selected the top three firms. Staff is seeking Council approval to enter into negotiations with Advanced Engineering and Design, Deuel and Associates, and Cardno TBE. Each firm has the expertise to provide general engineering services to the City and it was recommended to accept all three firms so that any of the three could provide engineering services to the City on an as-needed basis.

Motion made by Vice-Mayor Quinn seconded by Councilor Burke to approve the final ranking and authorize the City Manager to enter into negotiations with Advanced Engineering and Design, Deuel and Associates, and Cardno TBE to establish fees and terms for continuing services agreements.

Councilor Edelman inquired if the three firms were located within the City limits. City Manager Toney-Deal explained all three are within a similar radius and several of the Principals working for these firms live in the Seminole area.

City Manager Toney-Deal explained that the three firms, along with general engineering services, have specific "specialties."
