Vice Mayor Edelman inquired about the staging area on 84th Lane and he also inquired about the depression in the road on Burning Tree Drive. Mr. Due stated that he contacted Pinellas County on both issues.

Councilor Burke inquired as to whether we can change the speed limit on 86th Avenue and 70th Avenue from 25 to 30.

Councilor Barnhorn inquired whether the City Attorney could provide a workshop on the new Form 6 requirement. The City Attorney stated that he is not qualified to give a workshop on the Form 6, he advised that Council hire a professional in preparing the form.
