### FISCAL YEAR 2023-2024 MILLAGE RATE AND GENERAL FUND BUDGET

## A. ORDINANCE NO. 12-2023: ESTABLISHING THE MILLAGE RATE FOR FISCAL YEAR 2024 (OCTOBER 1, 2023 – SEPTEMBER 30, 2024)

City Clerk Mancuso read Ordinance No. 12-2023 in its entirety. City Manager Toney-Deal stated that staff recommended a millage rate of 2.4793 mills, which is an 8.47% increase over the rollback rate of 2.2856 mills. This is the same tax rate that the city has had in place since fiscal year 2008.

Mayor Waters opened the Public Hearing.

Receiving no requests to speak from the public, Mayor Waters closed the Public Hearing.

## B. ORDINANCE NO. 13-2023: ADOPTING THE BUDGET FOR FISCAL YEAR 2024 (OCTOBER 1, 2023 – SEPTEMBER 30, 2024)

City Clerk Mancuso read Ordinance No. 13-2023 by title only.

City Manager Toney-Deal stated that staff recommended a budget for fiscal year 2023-2024 with total expenditures of \$31,053,400. City Manager Toney-Deal identified all of the City's departments and their allocated budgets and identified the estimated revenues for the fiscal year 2023-2024. City Manager Toney-Deal brought attention to a proposed minimum 2% or \$1 per hour (the higher of) adjustment in pay for all non-union full and part time employees, and up to a 5% merit increase for all non-union employees.

## F. <u>RESOLUTION NO. 07-2023: AMENDMENTS TO THE CITY OF SEMINOLE</u> <u>CLASSIFICATION AND COMPENSATION PLAN.</u>

City Clerk Mancuso read Resolution No. 07-2023 by title only.

City Manager Toney-Deal stated that as detailed in Council's agenda packet, staff recommended the addition of three (3) new positions to the City's Classification and Compensation plan. In addition, the revised plan also includes a 5% increase to the minimum and maximum pay for exempt and non-exempt positions. The implementation strategy for adjusting pay rates will include an increase of \$1.00 per hour, or 2%, or \$15 /hour whichever is higher, to the base rate of pay for all exempt and non-exempt employees, both full and part-time, effective September 24, 2023. The change in salaries (2%) for Fire Rescue Union Personnel is allocated in the Fire Rescue budget. If approved, the Classification and Compensation plan will be effective in the first pay of October 2023.

## G. <u>AGREEMENT TO AMEND THE COLLECTIVE BARGAINING AGREEMENT WITH</u> <u>THE INTERNATIONAL ASSOCIATION OF FIREFIGHTERS, LOCAL 2896.</u>

City Manager Toney-Deal stated that the proposed amendment will implement a 2% increase in base salary for all bargaining unit employees, effective September 24, 2023. Additionally, the proposed agreement will raise the annual merit increase from 4% to 5% for annual appraisals between October 1, 2023 – September 30, 2024. The Union has to vote on the proposed Collective Bargaining Agreement (CBA) and upon approval, the revised contract will be signed by both the Union President and the City Manager.

It has been determined that the City does not have any property suitable for affordable housing.

City Attorney Daigneault stated that the determination is required to be made and complete by October 1, 2023, and then thereafter, every three (3) years.
