City Manager Toney-Deal stated that this project is in the Capital Improvement Plan and was approved by Council in the Fiscal Year 2024 CIP budget.

Public Works Director Rodney Due stated that the project is part of the ten-year Stormwater Implementation Plan. The plan is to eliminate the ditches and install stormwater pipe with inlets. Discussion ensued.
